RESOLUTION #14-20 AUTHORIZES EXECUTION OF FIRST AMENDMENT TO PILOT AGREEMENT RE: CALVERTON ADDICTION AND TREATMENT LLC

Thomas Cruso offered the following resolution, which was seconded by James Farley.

WHEREAS, by Resolution 16-18 adopted March 5, 2018, the Riverhead Industrial Development Agency approved the provision of financial assistance to Calverton Addiction and Treatment LLC Project as more particularly set forth therein, and

WHEREAS, a detailed analysis was performed of the Real Property Tax abatement as it related to school, county, town and fire district real property taxes which included an abatement of both the Riverhead Fire District Real Property Tax and the Manorville Fire District Real Property Tax as the Project is located within each of these taxing jurisdictions, and

WHEREAS, a public hearing was held upon due Agency notice to the affected taxing jurisdictions including the Riverhead Fire District and the Manorville Fire District, and

WHEREAS, customary Agency documents were drafted and prepared, by and between the Agency and Calverton Addiction and Treatment LLC and executed and delivered at closing dated as of August 1, 2018, including, among others, the Lease, Ground Lease, PILOT, Project Agreement, and

WHEREAS, it has come to the attention of the Agency that the PILOT Agreement executed between Calverton Addiction and Treatment LLC and the Agency referred to the Riverhead Fire District and did not state that a PILOT payment would be due to the Manorville Fire District, and

WHEREAS, the Real Property Tax bill for 2019/2020 for the Project (SCTM # 0600-135.00-01.00-007.56) was coded as Exempt as regards the Riverhead Fire District but was not coded Exempt as regards the Manorville Fire District and therefore the Manorville Fire District 2019/2020 Real Property Tax levy was paid by tax bill and not through the PILOT, and

WHEREAS, the Agency and Calverton Addiction and Treatment LLC desire to amend the PILOT Agreement to state that the Manorville Fire District Real Property Taxes are abated by the action and decision of the Agency pursuant to Resolution 16-18 adopted March 5, 2018.

NOW, THEREFORE, BE IT RESOLVED, that the Chairman or Vice-Chairman be and hereby be authorized to execute the attached First Amendment to PILOT Agreement on behalf of the Agency with Calverton Addiction and Treatment LLC, and

BE IT FURTHER RESOLVED, that the First Amendment to PILOT Agreement shall be recorded with the Suffolk County Clerk at the applicant's expense.

BE IT FURTHER RESOLVED, that the Executive Director shall prepare and file an Amended Real Property Tax Form 412-a with the Riverhead Board of Assessors stating that Calverton Addiction and Treatment LLC Facility is exempt from Real Property Taxes levied by the Manorville Fire District as well as the Riverhead Fire District as provided by Resolution 16-18 of the Agency.

RESOLUTION #15-20 FINALLY DETERMINING INCREASE OF TOTAL PROJECT COST FOR CALVERTON ADDICTION AND TREATMENT LLC FACILITY

Thomas Cruso offered the following resolution, which was seconded by James Farley.

WHEREAS, by resolution #50-19 adopted December 2, 2019 entitled "RESOLUTION AUTHORIZING INCREASE OF TOTAL PROJECT COST FOR CALVERTON ADDICTION AND TREATMENT LLC FACILITY" the Agency determined the total project cost for Calverton Addiction and Treatment LLC (the "Project"), and

WHEREAS, upon application of the Company an evidentiary hearing regarding the matter was scheduled to be held February 3, 2020, and

WHEREAS, upon a review of all matters concerning the cost increase and appropriate Agency fee, the Agency hereby finally determines the increase of total Project cost for Calverton Addiction and Treatment LLC.

NOW, THEREFORE, BE IT RESOLVED, that resolution #50-19 dated December 2, 2019 is hereby affirmed in all respects and the total authorized Project cost for the Calverton Addiction and Treatment LLC facility is hereby determined to be \$89,639,494., and

BE IT FURTHER RESOLVED, in reviewing all facts and all circumstances attendant to the appropriate Agency fee to be charged, it is hereby determined that the Agency fee for such increase shall be \$100,000.00. to be paid by the applicant within 15 days of the date hereof, and

BE IT FURTHER RESOLVED, that upon certification by the Company that the facts and statements made in this resolution are correct in the form stated herein, the Executive Director shall amend the Agency filings with PARIS to state this amendment to the total project cost.
