The intent is the make the 1100 sq ft upstairs into two market rate apts and gut renovate the downstairs for another restaurant. He has courted an Executive Chef whom has Blackstone and the Dory on his resume. It will be a new entity, new restaurant offering international cuisine and entertainment. Jason Breitstone and David Shorenstein are the principals of Hildreth Advisors. They have 3 other properties in Riverhead, but most of their work has been in NYC. They formed Hildreth Advisors approximately 2 and half years ago.

Whereas the operations of Atlantis Marine World, LLC has been negatively impacted and the applicant has requested assistance from the Agency to mitigate the financial consequences of the pandemic.

Whereas, through proceedings held, the Agency approved the application for financial assistance by Atlantis Marine World, LLC for the Project located at located at 431 East Main Street, Riverhead, New York (S.C.T.M. No. 0600-129.000-0004-021.003) which approval authorized the Agency to enter into a certain Payment In Lieu of Tax Agreement ("PILOT") which was duly executed by the Agency and Atlantis Holding Company, LLC and filed with the Riverhead Board of Assessors as amended on February 17, 2016 along with Real Property Tax Law form 412-a, and

Now, Therefore, Be It Resolved, that Payment In Lieu of Tax Agreement dated as of January 15, 2016 by and between the Riverhead Industrial Development Agency and Altantis Marine World, LLC be and hereby is amended as follows: the annual PILOT payment shall be payable in four equal installments at the option of Altantis Marine World, LLC upon the payment of an annual fee of \$500 by separate check with the first installment to be paid no later than January 10th, the second installment to be paid no later than May 31st, the third installment to be paid no later than August 31st and the fourth installment to be paid no later than November 30th for the 2020/2021 and the 2021/2022 Tax Years subject to an application for extension as necessary under circumstances created or related to the pandemic. Delinquent PILOT payments must be paid in full with all applicable penalty and fees, and

Be It Further Resolved that this resolution shall take effect immediately upon amendment to the written agreement as accepted and agreed. Thereafter a copy of this resolution shall be provided to the Riverhead Board of Assessors and the affected taxing jurisdictions.

No. 0600-128-6-22) which approval authorized the Agency to enter into a certain Payment In Lieu of Tax Agreement ("PILOT") which was duly executed by the Agency and Thirty West Main, LLC and filed with the Riverhead Board of Assessors on February 26, 2014 along with Real Property Tax Law form 412-a, and

Now, Therefore, Be It Resolved, that Payment In Lieu of Tax Agreement dated as of January 24, 2014 by and between the Riverhead Industrial Development Agency and Thirty West Main, LLC be and hereby is amended as follows: the annual PILOT payment shall be payable in two equal installments at the option of Thirty West Main, LLC upon the payment of an annual fee of \$250 by separate check with the first installment to be paid no later than January 10th and the second installment to be paid no later than May 31st. Delinquent PILOT payments must be paid in full with all applicable penalty and fees, and

Be It Further Resolved that this resolution shall take effect immediately upon amendment to the written agreement as accepted and agreed. Thereafter a copy of this resolution shall be provided to the Riverhead Board of Assessors and the affected taxing jurisdictions.
